Financial advisory companies choose how they share your personal information. Federal lawgives consumers the right to limit some but not all sharing. Federal law also requires us to tellyou how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and may share depend on the services we provideto you. This information can include:

- Contact information
- Social Security number
- Income-related information
- Account information, such as balance and transaction history
- investment experience
- Tax information

When you are *no longer* our client, we continue to share your information as described in this notice.

How?

All financial advisory companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial advisory companies can share their customer's personal information; the reasons The Colony Group, LLC ("Colony") chooses to share; and whether you can limit this sharing.
